- Police Report January 2023 Thorpe End 0, Little Plumstead 8, Great Plumstead 2
- County Councillor Report Councillor Mackie has met with neighbourhood and engagement police in the last two weeks to discuss local matters, mostly highway concerns. The issue of the unofficial bike and car meets, especially on Broadland Business Park and A47 was raised. This is an ongoing issue, especially in the summer. The police are currently undertaking various activities, which Councillor Mackie couldn't elaborate on. There will be plans to tackle anti-social behaviour. This was also raised with the Police and Crime Commissioner at a recent meeting in Thorpe.
- **District Councillor Report** For a second year in a row BDC is freezing its portion of the Council tax. Councillor Vincent confirmed that no services were being cut to be able to do this. This was achieved by a number of reasons included maintaining services and the move to the new building will reduce costs. The County Deal consultation closes on the 20th March, all papers and details are on the website. The consultation for the gypsy and traveller sites has been extended to 20th March. Details are available at www.gnlp.co.uk. BDC continues to reduce its carbon footprint to achieve net carbon zero by 2030. Action already taken or currently being implemented will see over an 85% reduction in its carbon footprint, these include greener fuel in our waste collection fleet, improving the buildings and replacing streetlights with led lighting.

7. TO DISCUSS PARISH PROJECTS

a. GREAT PLUMSTEAD RECREATIONAL PROJECT - UPDATE

The quantity surveyor valued the project at £2m which makes it unviable for the Parish Council. The project will be relooked at and will go for a more pre-fabricated building. The footprints will be kept the same but will better buildings. Unfortunately, the architects didn't stick to our budget of £500,000 which was stated at the time of the tender process. The Clerk will organise a meeting with the architects and the Councillors to discuss the project and also the latest submitted invoice. The Councillors did not agree the invoice, it is based on a final figure given by the quantity surveyor and not the tender figure. The Councillors discussed that it should be discussed with the architects that the project with them might be at an end. Proposed Councillor Cawdron, Seconded Councillor Johnson. All agreed.

b. ROSEBERY FIELD - OPENING DATE AND UPDATE

The field is due to be opened on 15th March. The dog bin and "dogs in lead" signage has been erected. The carpark will not be opened for the time being.

c. PADGATE PLAY AREA - UPDATE

Sutcliffe have confirmed that the project's start date will be the 18th April 2023. The site is likely to be closed for a month but it may open earlier if works run smoothly.
