- **County Councillor Report** Councillor Mackie has been involved in launching the warm room in Thorpe St Andrew together with a grant scheme. Please visit www.norfolk.gov.uk/safety/norfolk-winter. St Williams Way library has a raft of activity days and events, together with warm packs and hygiene packs. No questions asked. The County Council leadership is continuing with its support for a county deal for Norfolk. More information will come out early in the new year. The County Council has been consulting on a range of proposals and council tax rates in order to close the budgetary gap for 2023/24. The original proposal was for a 2.99% tax increase with a top increase before requiring a referendum of 4.9%. The final set of proposals will be published later this month, all comments must submitted before the 16th December. Little Plumstead Primary School is moving into academy status. Parents who are concerned about STREP A and Scarlet Fever 10 children especially under year olds can find more informed in at www.improvinglivesnw.org.uk/group-a-streptococcus-gas-and-scarlet-fever/, the Countv Council Public Health Service is monitoring closely. The OFSTED report on NCC Children's Services and Safeguarding is awaited.
- District Councillor Report Broadland DC have launched a new app for bin collections which will be available from 19th December 2022. The devolution of Government powers to Norfolk moved another step closer with the "in principle" Deal for Norfolk being signed. Next stages will see further negotiations with Government Ministers with details coming to NCC meeting in January 2023, a consultation in Spring/Summer of 2023, new legislation making its way on to the statute books Summer/Autumn 2023, the final decision being taken by NCC in December 2023 that will result in elections in May 2024 for a "directly elected leader".
- **Public Participation** The broken dog bin on the pathway between Morris Drive and Nelson Drive on The Glade, Little Plumstead has been reported but it's not maintained by the Parish Council. Councillor Heath believes this is the ownership of Whimpey and the Clerk will report this to them as its well used.

7. TO DISCUSS PARISH PROJECTS

- a. UPDATE FOR THE GREAT PLUMSTEAD RECREATIONAL GROUND PROJECT The Parish Council met with the architect and the Scouts onsite to plot out where the potential building will sit. It was noted that the current ramp for the brick Scouts building will need to be removed and the Scouts suggested a moveable ramp is a suitable replacement. The Bowls are happy with the plan for their site.
- b. TO DISCUSS AND AGREE A QUANTITY SURVEYOR FOR THE GREAT PLUMSTEAD RECREATIONAL GROUND PROJECT

The Parish Council has received two quotes for a quantity surveyor for this project, the recommendation is for Daniel Connal Partnership. Proposed – Councillor Bullen. Seconded – Councillor Carty

c. TO DISCUSS THE ROSEBERY FIELDS PROJECT. UPDATE ON COSTINGS AND APPROVAL OF SIGNAGE

FSG has sent through a draft for the proposed signage. The Councillors decided on black legs for the sign and to change the name of Rosebery Field rather than Rosebery Fields. The Parish Council has received one quote for the hedge cutting for the site but extra quotes will need to be gathered, the Councillors suggested Norse and the Clerk will see what companies other parishes use. There was discussion about the works which AGA have done and whether the invoices can be paid or disputed. The Clerk will circulate the invoices and investigate whether the works have been completed as per the contract or not.

d. UPDATE AND AGREEMENT FOR PADGATE PLAY AREA ADJUSTED QUOTE Sutcliffe have adjusted their quote to include removal of the existing gates and installation of new gates. The previous quote was for £77711.15, inclusion of the gates gives a total now of £82041.10. Proposed – Councillor Vincent. Seconded – Councillor Claxton. The Clerk has discussed this project with Broadland District Council and they have suggested using Section 106 Monies instead of CIL. Proposed Councillor Knowles and Seconded Councillor Heath.
