- Police Report Thorpe End 0, Little Plumstead 9, Great Plumstead 5
- County Councillor Report The County Council has a new leader, Councillor Kay Mason Billig. After an extension review there will be a revised set of timetables issued for the mobile library routes. Councillor Mackie has spoken with Mr Pearson of Highways about the schools request for H Bars and zig zags lines on the road to help with the parking issues. The Councillors asked for the Clerk to report the following to Councillor Mackie: Flooding on Hare Road, needs to be pumped out. Salhouse Road, the flooding is worse then ever. The gullies and ditches on Salhouse Road need clearing out. The Astley Road entrance grate needs clearing out as the area keeps flooding.
- District Councillor Report Application for the 2023 Veolia Sustainability Fund opened on 21st April. The fund supports projects which have both social and environmental benefits. Information and to apply go to https://www.veolia.co.uk/sustainability-fund. BDC has secured substantial funding from the public sector decarbonisation scheme. This will be used to refurbish the Horizon Centre with an energy efficient heating system, work should be completed by March 2024. All street and footway lights owned by BDC will be upgraded to LEDs to reduce energy costs and carbon emissions. Timers will also be fitted. Nutrient Neutrality concerns affect 5 districts in Norfolk and approximately 17,000 homes has been held up. A Joint Venture Company has now been set up to trade offset credit and the website is expected to go live in the next few weeks. The Joint Venture Partnership is bidding for government funding to support its work. BDC election held on 4th May 2023 has resulted in 47 councillors being elected in the following proportions: Liberal Democrat 14, Labour 8, Green 4 and Conservative 21. Councillor James Harvey thanked the residents in the Plumstead Ward for electing him. Councillor Vincent reported the following: Woodland Walk, Thorpe End – this has been visited and the excessive growth areas tackled and cut back. Road Sign Replacements, Brick Kiln Road - two road signs area logged for repair/replacement. Street Light, Sepping Way – this has been reported for repair.
- Public Participation Councillor Jones asked how the Tennis Court in Great Plumstead is set up, whether there is a lease in place. The Clerk will have a look at the paperwork which

she has. The Parish Council received a number of complaints about the grounds maintenance – Rosebery Road needs to be cut, Broadmead hasn't been cut, greens on Plumstead Road, Thorpe End and the Padgate Hedges need cutting.

11.TO DISCUSS PARISH PROJECTS

a. GREAT PLUMSTEAD RECREATIONAL AREA PROJECT UPDATE

On the monies which the Parish Council which holds at the moment the Parish Council can only undertake the project for the Scout Hut and Changing Rooms, with the Bowls Club coming when further monies are received. We will look into grant funding for the buildings. Councillor Knowles will finalise the positioning of the buildings and will then go out to the Scouts and Bowls for their agreement.

12.TO DISCUSS WROXHAM FC PLAYING AT GREAT PLUMSTEAD RECREATIONAL GROUND

Councillor Heath has been approached by two teams which were formerly part of Wroxham FC but will join with Norwich United who would like to play at the Great Plumstead Playing Field. The team would like to use the field for potentially all Saturdays. We would have to have a look at grounds maintenance may need to have it more frequently cut and carefully. The dog fouling is still a major problem.

13.TO DISCUSS THE LITTLE PLUMSTEAD PRIMARY SCHOOL'S REQUEST FOR ROAD LINES ON OLD HALL ROAD, LITTLE PLUMSTEAD

The Primary School has approached the Parish Council about their proposal for an enhanced hatched box outside of the school gates and then zig zag lines down Old Hall Road. The local police officer raised concerns about the lines as they would be enforceable at all times, rather than just at school times. The Parish Councillors were concerned about any road lines going down the length of the road as this may push the problem onto the other roads and also affect the residents. It was queried whether the hatched box could be extended and something on the corners to make the area safe for children crossing. The Clerk will speak further with the police.
