- Police Report August 2023 Thorpe End 3, Little Plumstead 8, Great Plumstead 3
- County Councillor Report Councillor Mackie met with Highways to confirm the location of the white gates on Salhouse Road, Little Plumstead. Councillor Mackie has also asked for 30mph road painted signs to be installed as you come into Little Plumstead from the Brick Kilns junction. NCC has launched a new website www.travelnorfolk.co.uk to help people get around the county more easily. The government appears to have signalled its funding commitment to the Norwich Western Link to complete the NDR. This was listed at number 38 in a long list of projects that will be funded instead of the Manchester to Birmingham HS2 project. Public consultation for the NCC budget will be undertaken over the autumn. The current proposals include a Council Tax increase of 4.99 per cent, including the adult social care precept of 2 per cent. The County Council is joining others across the country to attract a further 6000 foster carers across England. NCC information on becoming a foster carer. what it might mean and how you can be supported to foster can be found on the Norfolk County Council website. Residents, landowners, community groups and schools in Norfolk are being encouraged to join a new push aimed at increasing the number of trees planted throughout the county. Tree packs will be available at seven collection points across the county including Norwich (County Hall and Broadland Country Park), Acle, Long Stratton, Watton, Fakenham and King's Lynn. Those wishing to purchase a tree pack will be able to apply online from 13th September, packs will be ready for collection in the planting season December 2023 February 2024. considerably for a B&B from the care home. Therefore, proposed parking bays and cycling bays should be defined. As we noted previously, there is no identified kitchen/dining room unless within the domestic property adjoining. There is a note within the application document which states that opening hours are not relevant. Should this not be defined? In principle, the change of use for the property to residential and Bed and Breakfast is not objected to, but vehicle use will increase and the same main entrance is now proposed for the pig rearing facilities and accommodation behind the Heath Farm complex, placing HGV's in proximity. Our neighbourhood plan asks for the assessment of traffic movements arising from development and potential amelioration and intensification of use should be clarified. There are 7 bedrooms proposed for use plus the residential use, plus the existing business, plus the pig farm.

7. TO DISCUSS PARISH PROJECTS

a. GREAT PLUMSTEAD RECREATIONAL PROJECT - CURRENT SITUATION

The tender document has been put onto Contract Finder and into the local newspaper. Councillor Cawdron and Knowles will meet with the clerk to open these once they are received. The Clerk mentioned that there is a possible option of borrowing from Broadland District Council against future CIL payments, this would not be for the full amount of the project but to make up the potential shortfall from the late payments of the Salhouse Road development. The Clerk has found a couple of grants which could possibly be applicable for the project and will look into these further. Councillor Heath will make an application to the Football Foundation for a possible storage facility (up to £25,000) and portable flood lights.
