• Police Report – February 2024 -Thorpe End – 3, Little Plumstead – 3, Great Plumstead - 0

- County Councillor Report Hare Road, Great Plumstead There were some unexpected encounters regarding the trial holes and this study, namely the National Grid pipe. This issue has been overcome and the team have now received the trial hole data and plan to work this next week to adjust the drainage model to accommodate the pipe and other matters. The team leading the work are hoping to then have a meeting with the landowners to discuss options. Flooding issues on Hospital Road, Little Plumstead has also been looked at. The next round of Highways and Environmental funding is now open, if there are any schemes that the Parish Council knows of, these should be discussed with Councillor Mackie. The latest briefing regarding the Norwich Western Link is available on the Norfolk County Council website. The latest edition of the Your Norfolk Magazine is available and residents should have received a copy, or this is available on the Norfolk County Council website. Nominations for the new Rural Business Awards in partnership with the RNAA is open until 19th April. Improved buses to Thorpe End via the City5 Service with later services and earlier morning services starting on 15th April. The bus fares have been capped by the government to £2 until 31st December 2024. Councillor Heath confirmed that the road conditions on Hospital Road (outside of the Octagon entrance) are worsening due to the standing water. Councillor Bullen confirmed that there is a very large pot hole under the Hare Road flood, together with the road from Hare Road to Toad Lane in very bad condition. The road needs to also be cleared of silt. Councillor Knowles asked for Councillor Mackie to pass along compliments to the Highways team who resurfaced the Plumstead Road in Thorpe End for a job well done.
- District Councillor Report Green Lane Development The design work on the footpath both on Broad Lane and Plumstead Road are ongoing with Norfolk County Highway's and approval is subject to NCH timescales. Saffron Homes are still aiming to submit housing proposals to Broadland through the reserved matters process in late spring/early summer. Little Plumstead Hospital Councillor Harvey has been engaged in conversations with residents around the proposed resurfacing of the Little Plumstead Hospital overflow carpark and awaiting confirmation from the planning officer on whether the application will be rejected or not. It appears the car park should never have been a car park as its just the remains of the foundation from an old house and the road should have been removed with the developers completed their work. Hare Road development information received from the

developer on their plans to mitigate flooding and road safety issues, these all appear positive, however residents continue to raise concerns. BDC has received over £9.6m of capital and revenue funding to administer a Nutrient Mitigation Fund. Recent correspondence with the Head of Passenger Transport at Norfolk County Council has confirmed that the financial options for Postwick Park and Ride are still being reviewed. Passenger journeys are on average 1500/week which is well below ideal viability figure of 4500/week. Konectbus is looking at the service provided to the east of Norwich and whether it could possibly be extended.

For information – 20211743 – Land North of Smee Lane, Great Plumstead – The Clerk will speak to the planning officer to see if there is further information about the school provision. The Parish Council will also speak with the planning officer to start the discussion about the Section 106 Agreement and ensure that any funds are directed to either identified parish projects or to allow the monies to be parish wide for future projects. The Councillors will also review the application to ensure that the parking provision for the different types of houses meet the Neighbourhood Plan requirement.

7. TO DISCUSS PARISH PROJECTS

a. TO DISCUSS AND AGREE THE REPAIRS TO THE TRIM TRAIL IN PADGATE PLAY AREA

Two quotes have been received. The Parish Council agreed to go with RJW Carpentry. The quote is for replacement support pieces on either side and one upright post on the trim trail, total cost £450. The Clerk will ask for the work to be undertaken as soon as possible. Proposed – Councillor Bullen. Seconded – Councillor Knowles. All agreed.

b. TO DISCUSS AND AGREE THE INSTALLATION OF A NEW SHED IN THE WALLED GARDEN. LITTLE PLUMSTEAD

The Committee at the Walled Garden has asked if the Parish Council will allow them to install a large shed behind the shop (not blocking up the back entrance to the Walled Garden). The Parish Council has no problems with this request but asked if they can provide a new plan showing all the sheds/greenhouses etc which are located in the Garden which belong to the Committee. Proposed – Councillor Heath. Seconded – Councillor Jones. All agreed.

Clerk also confirmed that unfortunately the works to the new school carpark were not undertaken last year to clear away the weeds and ivy but this has been chased again. Hopefully this will be done soon.

c. TO DISCUSS THE GREAT PLUMSTEAD RECREATIONAL GROUND PROJECT

The District Councillor confirmed that he had received the following comments from a parishioner about the Project –

The amount of land lost to the changing rooms – The Parish Council ask all parishioners to view the planning application online to view the plans included. The Councillors have worked hard to ensure that there is minimal loss of playing field for the changing rooms. The loss does not affect the space provided for football or the ability for groups to host events like the Fireworks Night and the May Day Fayre.

Field will be developed – With the provision of changing rooms the Parish Council do not have any plans to developed the area further. The Changing Rooms will ensure that the field will be used for sports in the future.

How the development is being funded – the monies for the development are generated from Community Infrastructure Levy and Section 106. The Section 106 monies are directed to the Recreational Area and have to be spent here. No precept monies are being used to fund the development.

Dogs Banned – The Parish Council will not be banning dogs from the field once the development is completed. As previously stated by the Parish Council dogs may be banned in the future should people continue to leave their dogs' mess around the field and also let them into the childrens' play areas.

Sport England have responded to the planning application, with no material objection. They did submit a few comments which we have shared with David Bullen Limited and are discussing. The Councillors and Ben Bullen (Project Manager) will go through the comments raised and whether any adjustments need to be made to the application.

d. TO DISCUSS THE QUOTES RECEIVED FOR INSTALLATION OF THE BENCHES AROUND THE PARISH

A quote has been received to install the 3 benches into Thorpe End. The total cost for all three benches installation is £195. The Councillors agreed to go with the quote from Mark Appleford. It was noted that there is a plaque on one of the benches which will need to be removed and reinstalled on the new bench. Proposed – Councillor Knowles. Seconded – Councillor Jones. All agreed.

8. SUCCESSION PLANNING FOR THE PARISH COUNCIL'S ASSETS AND MAINTENANCE

The Parish Council have started to think about the future and planning for when there are changes with Councillors etc. The Parish Council is responsible for a large amount of assets which need to be regularly inspected and maintained.
